ORDER

Cancellation of appointment of candidate under Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020, notified vide S.O 192 dated 17.06.2020 and S.O 193 dated 17.06.2020 for the post of "Junior Staff Nurse" Health and Medical Education Department (Govt. Medical College Kathua), Divisional Cadre, Jammu Advertisement/Item No 08/2019/005.
