TERMS & CONDITIONS:

1. The Candidate must be a domicile of UT of J&K.
2. The hiring is purely on contractual basis for a period of one year which will be renewable on year to year basis subject to good performance and conduct or till the continuation of centrally Sponsored Scheme, whichever is earlier
3. The appointing authority shall have the right to terminate hiring without assigning any reason.
4. Candidates are requested to submit all the mandatory prescribed/requisite documents alongwith Application Form well before the Last date to avoid last minute rush. In case the mandatory prescribed/ requisite document is not submitted with the application form, candidature of the applicant is liable to be rejected without any further notice.
