Subject: Disengagement of Ms. Ekta Khajuria, Technician/Technical Assistant engaged under SRO-24 of 2019 dated 10.01.2019 read with SO-364 dated 27.11.2020.

Whereas, Ms. Ekta Khajuria was engaged as Technician/Technical Assistant in Government Medical College, Kathua under Advertisement Notice No. GMC/R/Estt/Rajouri/469-75 dated 11.01.2019 issued in terms of SRO-24 dated 10.01.2019 governing engagement on Academic Arrangement Basis; and

Whereas, pursuant to her selection, she was appointed vide Order No. GMC/K/Admn/2019-20/80 dated 03.04.2019 and joined her duties in Government Medical College, Kathua on 03.04.2019; and

Whereas, the terms and conditions of her engagement specifically provided that the engagement was purely on Academic Arrangement Basis for an initial period of one year, extendable from time to time subject to satisfactory performance and requirement, in accordance with the provisions of SRO-24 dated 10.01.2019, now read with SO-364 dated 27.11.2020; and

Whereas, Clause 4(1) of SRO-24 dated 10.01.2019, now read with SO-364 dated 27.11.2020, provides that the extension of engagement so granted shall not, under any circumstances, extend beyond a period of six years or till the posts are filled up on a regular basis by the competent authority, whichever is earlier; and

Whereas, before joining on Academic Arrangement, Ms Ekta Khajuria had voluntarily furnished an Affidavit/Undertaking accepting the terms and conditions of SRO-24 of 2019 dated 10.01.2019, wherein at Point No. 1 she unequivocally declared as under:

"That I have understood the terms of SRO-24 of 2019 dated 10-01-2019 and shall abide by the terms and conditions of the said SRO."

Whereas, Ms. Ekta Khajuria completed the maximum permissible period of six years of engagement on 02.04.2025; and

Whereas, no formal extension order has been issued in favour of Miss Ekta Khajuria after the expiry of the maximum permissible tenure, and in view of the bar contained in Clause 4(1) of SRO-24 read with SO-364, no extension beyond six years can be granted under any circumstances.



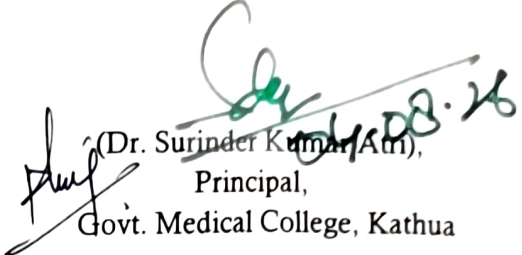
