As per latest guideline from Administrative Department, candidates need not to route their application forms through the Administrative Department. Application form should be submitted in the office of the undersigned. However, no candidate shall be allowed to participate in the selection process without prior approval of the Administrative Department. 3.) In case of selection, they will be allowed to join only after being relieved from their Administrative Department.

b.) FOR CANDIDATES WHO ARE NOT IN GOVT, SERVICE:- (Non-PSC Candidates)

 The Non-PSC doctors shall be engaged on consolidated pay equal to the revised basic pay which corresponds to the minimum of the pre-revised scale for post of Medical Officer in Health Department as per SRO-193 dated 24-04-2018 + dearness allowance. The appointee shall also be entitled to house rent allowance as applicable to in-service candidates carrying the minimum of the pre-revised scale of the post subject to fulfilment of the conditions provided under the
