GOVERNMENT ORDER NO:-122-JK(HME) OF 2020 D A T E D:-04 - 02 - 2020

WHEREAS, with regard to the Institutions located outside J&K viz., Institute of Public Health and Hygiene, Mahipaipura, New Delhi, Sai Institute of Allied Sciences, Channa Patana Ramnagram, Karnataka and Institute of Paramedical Technology, Pahari Chatterpuri, New Delhi, in respect of which the Government of Jammu and Kashmir had from time to time granted recognition to the paramedical courses being undertaken by the students of J&K in these institutions, it was, vide Government Order No.828-HME of 2019 dated 18.09.2019, ordered as under:-

"Now, therefore, the general public is hereby informed, that no Paramedical Institution outside the State is at present recognized by the Health and Medical Education Department, J&K for imparting Degree/Diploma Courses in various disciplines for the students of J&K and that no extension in recognition has been granted in favour of any of the above three Institutions beyond 2016 and also that the Degrees/Diplomas obtained by the students of J&K from these Institutions beyond the above stated period shall not be considered as valid for applying for various posts of the Health and Medical Department as may be advertised by the J&K, SSB".

AND WHEREAS, a representation was received in the Health and Medical Education Department from one of these Institutions requesting therein for issuance of necessary modifications in the above referred to Government Order so that the candidates who have obtained

Diploma/Degree courses from the said Institution are not deprived of their right to apply for various posts of Health and Medical Education Department as are advertised by the J&K Services Selection Board;

AND WHEREAS, the matter was examined in the Health and Medical Education Department and the issue was taken up with the J&K Paramedical Council for comments;

AND WHEREAS, the President, J&K Paramedical Council informed that detailed deliberation were held on the issue in the meeting of the J&K Paramedical Council held on 23.11.2019 and it was felt that Government Order No.828-HME of 2019 dated 18.09.2018 regarding the Paramedical Institutions located outside Jammu and Kashmir has created some confusion in the minds of the students who are pursuing various paramedical Diploma/Degree courses from the institutions located outside Jammu and Kashmir and it was necessary that the operative para of the said Government Order is modified in a manner to remove the confusions, if any;

AND WHEREAS, the matter has further been examined in the Health and Medical Education Department in light of the suggestion of the J&K Paramedical Council and it has been felt to recast the concluding/operative para of Government Order No.828-HME of 2019 dated 18.09.2018 in a manner so as to avoid the confusions, if any, as may have arisen in the minds of the students pursuing Diploma/Degree paramedical courses from the institutions located outside Jammu and Kashmir.

Now, it is hereby ordered that the last para of Government Order No.828-HME of 2019 dated 18.09.2019, issued under endorsement No. ME/Legal/NG/196/2016-Genl, shall and shall always be deemed to have been recast as under:-

"Now therefore the general public is hereby informed that no individual NOC/Affiliation has been granted by the Government of Jammu and Kashmir to any institution situated outside Jammu and Kashmir including the above mentioned three institutions beyond 2016 and also that the J&K Paramedical Council shall register, upon completion of the course, the Diploma Certificates of the students admitted only during the affiliation periods by the above mentioned three institutions, after verification of Individual cases. However, the J&K Paramedical/Nursing Council shall register the Diploma/Degree certificates of the candidates who have taken training from Institutions situated outside Jammu and Kashmir which are duly recognized by/affiliated with different Paramedical Councils/Nursing Councils/Recognized Universities/respective State Governments."
