Subject: Operating of Waiting List of Junior Residents on Tenure Basis in various disciplines of Government Medical College, Kathua.

In continuation of the Advertisement Notice referred to above, and as recommended by the Selection Committee, the waiting list for the post of **Junior Resident** in various disciplines is hereby operated as per **Annexure-A** enclosed with this notice.

It is pertinent to mention that, out of the **32 Junior Residents initially selected**, **27 Junior Residents have joined** their respective departments. Subsequently, **04 Junior Residents have resigned**, resulting in **11 vacancies** of Junior Residents in various departments.

The candidates figuring in the waiting list shall be considered for selection/appointment strictly in order of merit, subject to availability of vacancies. In case a candidate fails to report within the stipulated period or fails to produce the requisite documents, his/her candidature shall be liable to cancellation without any further notice, and the candidate next in merit shall be considered.

ANNEXURE-B

The engagement shall, however, be subject to the following terms and conditions: -

1. Appointment shall be subject to work and conduct of the candidate in the college/Hospital/Dispensary remaining satisfactory during his/her tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other such activities which affect the hospital services/patient care, the tenure appointment of doctor shall be terminated without any notice.
2. The candidate shall be required to stay in the College/Hospital premise if residential accommodation is available and near college campus in case of non-availability of residential accommodation.
3. The candidate shall not indulge in any private practice during his/her tenure and if found doing so his/her tenure appointment shall be terminated forthwith
4. Salary shall be disbursed only after satisfactory report from Inspector General of Police, CID, J&K will be received.
5. The candidate intending to leave the institution shall have to provide one-month prior notice duly forwarded by the concerned HOD or else the candidate shall have to deposit on month salary in the institution.
6. In case of any interpretation and relaxation regarding the above terms and conditions is concerned the decision of the Principal, GMC Kathua shall be final.
