The appointment of the above candidate shall be subject to the following terms & conditions:

i) The appointee shall report in the office of Principal Govt. Medical College Kathua within the period of 21 days along with all the original certificates, two photocopies of all educational qualifications and other concerned certificates duly authenticated by concerned authority i.e Domicile Certificate, Category Certificate (if any) No Objection/Loan Certificate from District Industrial Centre, District Employment Exchange, Character certificate issued by the concerned Police Station and Medical Fitness Certificate duly signed by Chief Medical Officer.

ii) In case the appointee does not join within the said period (i.e 21 days) from the date of issuance of the appointment order, his/her appointment shall be deemed to have been cancelled ab-initio without serving any further notice.

iii) The appointee shall give an undertaking that he/she shall be required to stay in the college/ hospital premises if residential accommodation is available and near college/ hospital campus in case of non availability of residential accommodation.

iv) Verification/genuineness of the qualification certificates and the reserved category (if any) from the concerned issuing authority shall be carried out by DDO concerned.
